#### Retiree President's Report



Last issue I provided a list of things we have accomplished and some things we have been working on for our association over the past year. We have added a 'beginning history' of our association to our web site, but thanks to Lola Dixon, a founding member and our first President, I thought we might share some of her comments that may not previous been known.

"Since today's topic is of a historical nature, it seems that it is appropriate to give a brief historical report about the formation of our organization. Since the chart in the August "Tower Talk" referred to the 1980-2005 as 'the dark period', I felt that I needed to prove otherwise. It so happens, that in July 1990, the UC Riverside Retirees' Association was founded. Many of you here were involved. It was a lengthy process and brought to fruition hard work and organizational efforts by a small planning committee. According to the fall 1990 issue of the University of California system wide magazine 'New Dimension' with cover story "New Association fulfills an Old Dream" reported that about 100 people (which included then Chancellor Rosemarie Schraer) gathered in July 1990 to create the UC Riverside Retirees' Association. At that time, members elected a slate of officers. adopted by-laws, and set dues. The officers elected were: Lola Dixon, President: Ed Hanki, Vice President; Eleanor Buker, Treasurer, and Evelvn Middleham, Secretary. Throughout efforts, Chancellor Schraer greatly supported and encouraged us, and to our surprise, as requested, some of you remember when an office was assigned to us which was first in the Extension Center and then in the Highlander Hall. The office was staffed with volunteers for four hours during three days each week and retirees were encouraged to drop by. We all were "gung ho" and accomplished a lot. For instance, we provided volunteers for the campus, published a newsletter which we named 'Tower Talk' (sounds familiar?), sent membership rosters to all members, and even had Botanic Garden Wheelchair Tours (volunteers pushed the wheelchairs), etc. Of course, we had monthly board and General meeting with speakers.



#### **Programs and Services**

The Retiree Center currently provides the following programs and services to retirees, and employees preparing for retirement.

#### **Serves as a campus connection**

The Center will serve as an official unit representing the needs of retirees to the UCR campus.

- Supports the work of the Emeriti and Retirees' Associations
  - The Center will provide support to the UC Riverside Emeriti Association (UCREA) and the UCR Retirees' Association (UCRRA), both of which provide educational programs and advocate for retirees at both the university and state levels. Monthly luncheon seminars will focus on university happenings as well as retiree issues.
- Plans social/educational programs
  - The Center can plan a variety of social events and educational programs for retirees. Social activities provide opportunities to reconnect with colleagues. Quarterly day trips allow retirees to travel to regional sites with ease. Educational programs keep retirees abreast of important issues. The Center's Activities page lists upcoming events and trips.
- Connects retirees with campus volunteer opportunities
   Retirees can serve the Center by joining the Center's advisory committee or assisting with events or administrative tasks.
- Provides information and referrals
  - The Center can provide information and referrals to professional resources. The Center's Resources page links to many local and national governmental resources such as Medicare and Social Security, as well as a variety of community agencies.

  - The Center can coordinate with other offices at both Riverside and the health system to provide and publicize pre-retirement planning and counseling programs for current employees.
