

## **HOW TO HELP YOUR SURVIVING BENEFICIARIES**

It is important to plan ahead for end of life. Summarized below are suggested tips and resources to help you and your surviving loved ones be prepared to take on the transactional details of one's passing.

## TIPS **Create a Survivor Folder** Create a folder that includes important documents such as UC Retirement plan final documents noting benefit election, health and welfare benefits, a will, living trust, health care directives, your spouse's and/or children or beneficiaries birth certificates, marriages, evidence of name changes, social security numbers, key UC contacts and resources. **Update Beneficiaries** Ensure that you have updated your beneficiary designations and keep them up to date using your UCRAYS self service account so that the loved ones that you intend to receive your benefits are listed. Notify beneficiaries so that they can expect the benefits they may receive in the future. Identify a Point of Contact Designate a point of contact from your loved ones who will manage the interactions with UC's Retirement Administration Services Center (RASC). It is often recommended to not be your grieving spouse. **Report the Death** Communicate with your loved ones the need to report the death to the RASC, local UC campus benefits office or retirement center as soon as possible to avoid delays in processing beneficiary benefits. **Order Death Certificates** Prepare your loved one to order multiple death certificates which can be retrieved from the vital records office in the

state where the death occurred, city hall or other records office. It is recommended to order twelve or more death certificates.
